<u>Step 2:</u> You will need to find and complete a National Pool Lifeguard Qualification (NPLQ) course.

The Priory Federation of Academies deliver a NPLQ course every summer at Priory City of Lincoln Pool, Skellingthorpe road, LN6 OEP. **ONLY £150!** Start date 22.07.23

To find other NPLQ opportunities in the local area, all NPLQ lifeguard courses are shown on the RLSS website. <u>https://www.rlss.org.uk/find-a-course</u> However, it is strongly recommended you call leisure centres/water parks local to you to ask when their courses are as they can get booked up quickly in advance of appearing online.

Other Course fees vary from £220

NPLQ Course Pre-requisites:

Every candidate attending a NPLQ course must be 16 years old at the time of taking the NPLQ final assessment and be able to:

- Jump/dive into deep water
- Swim 50 metres in less than 60 seconds
- Swim 100 metres continuously on front and back in deep water
- Tread water for 30 seconds
- Surface dive to the floor of the pool
- Climb out unaided without ladder/steps and where the pool design permits

Step3: Email <u>efrench@prioryacademies.co.uk</u> to celebrate your success at gaining your qualification! This will also trigger various employment paperwork that you will be sent from our reception team. You will be asked to have a Disclosure and Barring Service (DBS) check done and you will be expected to complete the Priory Safeguarding online training. **These must be completed before you can start working** so it's important you check and respond promptly to your emails even during the holidays.

Step4: In September, the pool staff will arrange a site specific induction, discuss timetables, rotas and let you know the ongoing training dates. Attending RLSS refresher training is an expectation and is provided monthly by the Priory LSST Academy.
